Job Purpose

Attention to detail and active engagement with delivery and support staff to monitor, improve and maintain high standards of compliance against the Education Skills Funding Agency requirements is key to providing high quality support and development making the department audit ready at all times. You will work within Awarding Body standards and guidelines, policies and procedures as well as wider quality frameworks, such as ISO-9001 and Matrix Standards.

- To co-ordinate and support the quality & compliance manager to oversee the quality improvement process across all our qualifications and standards and maintain the QIP.
- To work in collaboration with tutor/assessors, IQAs and other staff/managers to ensure active
 participation in all quality improvement processes including self-assessment, action plans and
 performance review meetings.
- To maintain quality improvement processes, tracking and reporting systems to ensure that achievement of performance targets are being met and that the department can evidence impact on learner's progress.
